
Highlights



Upcoming Retail Project Delivery – Texas SET v5.0


Texas Standard Electronic Transaction (TX SET) Version 5 Retail Market enhancements:

- Upgrades to Continuous Service Agreement logic to increase usability and efficiency
- Inclusion of County and Metered Service Characteristics and Reject options that expand routing and reporting
- Automated manual processes associated with inadvertent customer gains and customer's right of rescission
- Mandatory 'Flight' testing to begin 8/6 on new standards to validate Market Participant compliance
- Go-live Target: Nov 2024


